OFFICE ORDER

(Recruitment of Medical Lab. Technician)

The Punjab State AIDS Control Society (PSACS) invites **online applications** on prescribed proforma for filling up of vacant posts of Medical Lab. Technicians on Contractual Basis under National AIDS Control Programme of Punjab State AIDS Control Society (PSACS) in Integrated Counseling and Testing Centres (ICTCs) and Anti-retroviral Therapy (ART) Centres. The last date of submission of application is **15-06-2026**.

Number of vacancies: There are 11 vacancies (tentative- posts can increase or decrease) to be filled strictly based on the reservation roster. **Table 1** below provides the total and the category-wise number of vacancies. Candidates from other categories shall not be considered.

In case, the posts reserved for the ESM(General), ESM (Female-General), SC(ESM) and BC(ESM) is not filled from these categories, then these categories will be filled as under:-

ESM (General)

1. If a candidate of ESM (General) category does not apply for the said post then the lineal descendant of Ex-Serviceman general category will be considered.
2. If none of the candidates mentioned in the point 1 apply for the above said post then the post will be filled from the General pool of general category as per the reservation guidelines of Department of Defence Services Welfare, Govt. of Punjab.

ESM (Female-General)

1. If a candidate of ESM (Female-General) category does not apply for the said post then ESM (Male-General) will be considered for the post.
2. If ESM (Male-General) does not apply for the said post then the lineal descendant of Ex-Serviceman general category will be considered.
3. If none of the candidates mentioned in the point 1 & 2 apply for the above said post then the post will be filled from the General pool of general category as per the reservation guidelines of Department of Defence Services Welfare, Govt. of Punjab.

SC (ESM)

1. If a candidate of SC (Ex-Servicemen) category does not apply for the said post then the lineal descendant of SC (Ex-Servicemen) will be considered for the post.
2. If none of the candidates mentioned in the point 1 apply for the above said posts, then said posts shall be filled from general pool of Scheduled Caste category as per the reservation guidelines of Department of Defence Services Welfare, Govt. of Punjab.

BC (ESM)

1. If a candidate of BC (Ex-Servicemen) category does not apply for the said post then the lineal descendant of BC (Ex-Servicemen) will be considered for the post.
2. If none of the candidates mentioned in the point 1 apply for the above said posts, then said posts shall be filled from general pool of Backward Class category as per the reservation guidelines of Department of Defence Services Welfare, Govt. of Punjab.

Maximum age limit: The maximum age limit to apply is 60 years.

Qualifications and experience: The essential and desirable qualification and the essential experience for MLTs are shown in **Table 2**.

Salary: The MLTs shall be paid a consolidated salary of Rs.21,000/- per month.

The applicant should fulfill the eligibility requirements on or before the last date of submission of applications i.e. 15-06-2026 (last date of online Registration). No extension shall be given to any applicant to submit documents. If a candidate does not have eligibility documents such as category certificate issued by concerned department of Government of Punjab (or) educational degree then they will be declared ineligible at the time of document verification.

Last date for submission of online applications: 15-06-2026 (till 05:00 pm).

The question paper will comprise of questions on:-

1. Basics of HIV
2. HIV Testing
3. CD4 testing
4. Viral load testing

Instructions for written test:-

- The candidates should reach the venue one hour before the start of the exam.
- The question paper will be in English and will be of objective type MCQs.
- There will be no negative marking.
- Candidates will be given 1:30 hours for the examination.
- Candidates must bring one identity proof i.e. Aadhar Card/Voter Card with them.
- Candidates will not be paid any TA/DA who will appear for written test.
- The use of mobile phones or other electronic gadgets are strictly prohibited at the examination centre/venue.

Instructions for document verification (For candidates who will clear the written test):-

- The candidates are required to bring **original documents/certificates** comprising Academic certificates, experience certificates, Proof of passing Punjabi upto Matric standard or its equivalent standard from any recognized institution/Board or proof of passed the Punjabi Language Proficiency Test conducted by the Department of Languages, Government of Punjab, category certificate issued from Punjab Govt., Age proof and Photograph alongwith photocopy of all testimonials.
- **Additional time shall not be given to submit the certificates/testimonials.**

- In case candidate fails to produce any certificate/testimonial or found fake/forged on the day of document verification, the eligibility would be cancelled with immediate effect.
- Candidates will not be paid any TA/DA for attending document verification.

The selection criteria will be as under:-

- 1) Eligible candidates have to pass the written test (35% minimum passing marks).
- 2) The selection will be done based on the merit of marks obtained in the written test (100% weightage).

Other important terms and conditions:

- a. Interested candidates having the qualification mentioned against the post may submit their application online on the link <https://forms.office.com/r/QyGg2y0RVY>.

- c. **The candidate should have passed Punjabi up to Matric standard or its equivalent standard from any recognized institution/Board or should have passed the Punjabi Language Proficiency Test conducted by the Department of Languages, Government of Punjab.**
- d. Incomplete applications will be rejected.
- e. **Only on-line application forms will be entertained** i.e. application sent by email/post/courier or in person in the O/o PSACS will not be entertained and will be rejected.
- f. All particulars including category once filled by the candidates, could not be modified and no change shall be permitted at any stage in online application form once submitted. So, the candidates are advised to fill all their particulars after taking due care and precaution. PSACS shall not be responsible or liable in anyway.
- g. The number of posts is subject to **increase or decrease** as per the decision of the Project Director, PSACS.
- h. The certificate for the **claim of reservation** must be issued by the **competent authority**. The certificate must be latest one i.e. issued on or before the last date of submission of application form. No request for extension of submission of documents will be considered.
- i. These posts are purely **contractual and temporary for one year**, extendable based on work performance and conduct.
- j. Educational qualifications must be from a recognized University/Board. You should have all the requisite original certificates at the time of submission of the application. **Additional time shall not be given to submit the certificates/documents.**
- k. Provisionally eligible candidates from category as specified in the **Table-1** will be called to appear in person for **document verification. Original certificates/testimonials** will be checked at the time of document verification. **Additional time shall not be given to submit the certificates/testimonials.**
- l. The candidates who are found eligible after document verification will be called for written test.
- m. If a candidate is found not to be fulfilling the eligibility/selection criteria at any point of time in the entire recruitment process by the screening or selection committee, his/her candidature will be cancelled/rejected for the said post.
- n. Candidates **will not be paid any TA/DA** for document verification and written test.
- o. Project Director, PSACS, reserves the **right to cancel/modify** the entire recruitment process at any stage without issuing any further notice.
